16. The human papillomavirus (HPV) is one of the most common sexually transmitted infections and is linked to six different cancers, including vulvar, vaginal, anal, penile, oropharyngeal, and cervical. The Centers for Disease Control and Prevention (CDC) recommends HPV vaccination for everyone between the ages of 9 and 26 years. Barriers to HPV vaccination are diverse and are often framed by religious objections and medical mistrust. Factors influencing vaccination decisions include pain, fear, risk, parental and social influence. Social media platforms, such as TikTok, Facebook, and Instagram, facilitate the creation of online communities, offering users opportunities to interact with one another. Misinformation on social media has been found to contribute to vaccine hesitancy, potentially impacting HPV vaccination rates.

How do you propose to address this issue?

17. RXY a digital health company has teamed up with a Pharma giant to address the pain points of breast cancer through digital therapeutics. Pain, nausea, anxiety, lack of understanding of the treatment, and lack of adherence to treatment are the key pain points. Also, very often, the feeling of being alone, not being fully connected with the care team. They are proposing to roll out the product in India after obtaining regulatory approval.
